# CAMDEN COUNTY BOARD OF COMMISSIONERS MEETING February 18, 2021

The meeting was called to order by Director Cappelli at 12:06 p.m.

The Clerk called the roll and the following Commissioners answered:

It is noted for the record that due to the Coronavirus pandemic and inclement weather, all Commissioners participated virtually.

Due to the Coronavirus pandemic, the meeting was closed to in-person participation by the public. The public was availed the opportunity to participate via live streaming and to send in questions before, during and after the meeting.

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance.

The Director said good afternoon ladies and gentlemen. Welcome to the meeting of the Camden County Board of Commissioners. We will have four (4) First Readings at this afternoon's Commissioners' meeting. Public hearings on all four (4) matters will be held virtually on March 18, 2021 at 12:00 noon and will be streamed live via www.camdencounty.com/live. Members of the public are welcomed and encouraged to view and participate in the public hearings via the live feed.

#### FIRST READING

Bond Ordinance of the County of Camden, New Jersey appropriating \$1,000,000 in supplemental funding for the development and construction of athletic fields and related parks and recreational improvements at the former Campbell's Field site in the City of Camden and authorizing the issuance of \$950,000 Bonds or Notes of the County for financing part of such appropriation.

Director Cappelli asked for a motion to adopt the first reading of the Bond Ordinance. Commissioner Dyer made a motion with a second by Commissioner Nash and on roll call all Commissioners present voted aye.

## **RESOLUTION 52**

#### **NO MOTION MADE – FAILED**

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

<u>Stephen Meyer</u> - Question: *Will they be voting on hiring for the 9-1-1 Center?* Director Cappelli said those hirings are contained in this month's Personnel Actions under Commissioner Young.

Garren Steiner - 6650 Browning Road, Suite M20, Pennsauken. I am the President of CWA Local 1014. Two days ago, I submitted a letter which I was hoping would be addressed at today's meeting. One to the general email for this meeting as well as one to all of the Commissioners. I would like to know if you received my letter or, if not, if it would be ok if I read the letter out loud? Director Cappelli said we received your letter and we addressed it publicly at Caucus on Tuesday. What we learned after we addressed your letter was that apparently there were some delays in the negotiating process early on caused by a change in leadership with the union and then the pandemic but that recently negotiations have swung into full force and are ongoing. Hopefully, we will come to a fair settlement in the near future. Mr. Steiner said I appreciate your reading the letter. I don't know how much a leadership change delayed the process but nevertheless there was a change, that is correct. I want to drive home the notion that we have received a lot of good

feedback as noted in the letter from the Commissioner Board and we were hoping that in recognition of what was put down in writing that those sentiments will be echoed at the table. I appreciate your concern and hopefully we can push these negotiations forward. Thank you for your concern.

<u>Perry Levine</u> - Question: What is the status of the contract with Haleigh Cemetery regarding the Camden County Veterans Cemetery? Mr. Orlando of County Counsel said we are under contract with Harleigh for the Veterans Cemetery. Two years ago, we entered into a maintenance agreement with Harleigh where the County now provides the maintenance of that area of the cemetery. From reports that we have received, maintenance of that area is much improved from where it was before. We continue to negotiate with Harleigh regarding costs for other services.

<u>Perry Levine</u> - Question: Three recommendations were submitted regarding veteran issues. Will those be acknowledged? Commissioner Kane said we received those recommendations. The recommendations will be taken under advisement by the Advisory Committee. We will be discussing those recommendations with you through correspondence; however, they will not be addressed at today's meeting.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Deputy Director McDonnell made a motion with a second by Commissioner Dyer and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash wished everyone safe travels. To Al Dyer, who has been a Commissioner for all of two months, he said have had three snowstorms that he has been dealing with. Not for anything Al, but your predecessor had no snowstorms. In all seriousness, the Public Works crews have done an outstanding job dealing with traffic hazards created by these snowstorms. Commissioner Nash asked Commissioner Dyer to extend his congratulations to everyone at the department for doing a great job. I am sure they are going to do another great job today.

Commissioner Nash said I had an opportunity to tour the Vaccination Site at Camden County College. As all my colleagues know, the accolades have been flowing freely. They have done an outstanding job under the most difficult circumstances. Recently we administered our 10,000th vaccination. Their efforts to increase the number of vaccinations and expand the scope of the vaccinations continues.

Yesterday Director Cappelli and I had the opportunity to be with Governor Murphy, the Senate President and other officials to announce the \$250,000 upgrade to the Walter Rand Transportation Center. This is a great plus for the City and matches the revitalization of the City. For those of us who knew Senator Walter Rand and his vision for transportation in and around the City, this is a remarkable final upgrade that will connect PATCO, the Riverline and the soon-to-be constructed Gloucester Camden Line, the GCL, which is under preliminary engineering as we speak. With that I wish everyone safe travels and safe health.

Commissioner Young said I too want to congratulate PATCO and South Jersey for the Walter Rand Transportation Center. People do not realize the impact this will have on South Jersey. This makes South Jersey a true gateway which comes right through the heart of South Jersey. Being able to grab a train and get to Glassboro or Trenton over into Philadelphia is going to spur a huge amount of economic development. We are very excited about that expansion coming into the City of Camden. South Jersey is beginning to make a huge turn. In the coming years South Jersey is going to become something to reckon with.

I also visited the Vaccination Site today. As of 11:00 this morning they had vaccinated 850 individuals. They are looking to do a total of 2,000 today. I want to remind everyone to sign up to be vaccinated. Our food distribution continues. This Friday we will be in Lindenwold at the Department of Public Works. Due to the pending inclement weather, there is a time change. We will be there from 2:00 to 4:00 instead of our normal 10:00 to 12:00.

Commissioner Kane said I wanted to say to Al, we know you are powerful, but not that powerful to create snowstorms so please do not bear that responsibility yourself. In addition, to the wonderful work that Camden County has done with vaccinations, we have also partnered with the VA Medical Center in Philadelphia. Three weeks ago we had the opportunity to vaccinate 600 veterans from the area. They will be returning this Saturday to the Runnemede Community Center for their second dose. There are no walk-ups. Any veteran in Camden County that is 65 years of age or older, which is a change from the original age of 75, and is enrolled in the VA Health Care, can call 215-823-4014 to arrange an appointment from the VA. The partnership with the VA in Philadelphia is due to the relationship we have had with the VA for many years. It has been a great working relationship. I want to thank Frank Filipek and Kara Maxwell for their hard work in assuring that the VA's needs were met in setting up this vaccination site. I would also like to make note to our residents whose loved ones have served in the military and who have died of COVID, if they need assistance with filing a claim, they can call the Camden County Office of Veterans Affairs and the staff will assist family members with getting a DD214 or anything such as that. There are also resources available for family members if they call the Camden County Office of Veterans Affairs. They can provide resources and referrals for the family members who have lost a loved one from COVID. The local office for the County is 856-374-5801.

Commissioner Kane said, finally, I wanted to acknowledge the tremendous suffering that is taking place in Texas. We all wish we could do something other than just saying that they are in our thoughts and prayers which seems kind of empty at times. I would like to acknowledge that we know they are going through a lot of difficult times and hopefully the issues will be resolved as soon as possible.

**Commissioner Dyer** said first and foremost my thoughts and prayers continue to go out to those families who have been impacted by this terrible pandemic.

I would also like to reiterate something that Commission Nash said. Yes, I was elected, and I am glad I was elected as a Commissioner, but I did not bring this storm. It seems like since I came on board as a Commissioner it has snowed every other day. I am doing my due diligence and trying to get coverage and provide updates to everyone in Camden County. With that, I commend and praise those gentlemen who showed up at Public Works this morning at 5 a.m. to start their service and clear the roads in Camden County. Those guys have done a tremendous job. It feels great to go down there and see logistically how they perform their duties. We are very

proud of everyone at Public Works for doing a great job.

I also visited the Vaccination Site yesterday. I would like to acknowledge Dorothy Maria Ditto who turned 101 and received her vaccination shot yesterday. It was wonderful to converse with her. She is a very sharp young lady and it was great to be there when she received her shot. She says hello to the entire Commissioner Board.

**Deputy Director McDonnell** – Due to technical difficulties, Deputy Director McDonnell was unable to provide his comments.

**Director Cappelli** said I would like to thank all the employees of Camden County for the great job they are doing. From the vaccination site to plowing, all departments and members of our team are out there working so hard on behalf of the residents of Camden County. Many of them putting their own health at risk. We cannot thank them enough. Director Cappelli said I know I speak on behalf of the entire Board when I say we could not be more proud of the employees of Camden County for the work they are doing.

On a less serious note, I would like to say that I do not agree with the trade of Carson Wentz. Next year we will review how the season went.

The Director asked for a motion to adjourn. Commissioner Young made a motion with a second by Commission Kane and all Commissioners voted aye.

The meeting was adjourned at 12:30 p.m.
