- A response will be provided within seven (7) days.
- The request will be reviewed and redacted according to Daniel’s Law.
- Any response will be sent to the requestor via email which may include the MODIV link.
- The MODIV link will be available for a 72-hour period only.
- The MOD IV master will not contain owner, mailing address or deed book and page information.
- To acquire owner, mailing address or deed book and page information, you must complete a request and sign a confirmation that you have received and read a copy of “Daniel’s Law P.L.2020 c.125”.
- Requestor has a right to challenge and appeal any denial of this request. Appeal instructions will be provided with such denial.
