## Work Completed the Week of April 10, 2023:

Black Rock's pipe crew continued installation of drainage improvements along the eastbound lane between Crofton Commons and Kings Highway. The pipe crew installed 3 linear feet of 12" DIP, 3 Double B inlets, 6 inlet filters and excavated 3.7 cubic yards of test pits. Black Rock's guide rail subcontractor, Roadway Safety Systems (RSS), mobilized to the site to remove and replace the guide rail along the eastbound lane across from the Thomas Paine Elementary School. RSS removed 422 linear feet of existing guide rail and installed 360 linear feet of beam guide rail, 2 guide rail anchorages and 2 guide rail terminals.
