Work Completed thru October 14, 2024

- > Traffic Control Signage installed at either end of the project
- ➤ VMS installed
- FDR from STA $82+50\pm$ to $36+40\pm$ (started from opposite end of project)
- > Randomized testing of FDR each day
- Removed and replace ½ of storm crossing at STA 83+50

Summary of Work Completed Week of October 14, 2024

During the week of October 14^{th} , the contractor continued full depth reclamation (FDR) from STA $82+51\pm$ to STA $36+40\pm$ through Friday, October 18^{th} . Areas that required fill were graded to match the proposed grades. Samples for testing were taken at STAs 82+00, 72+70, 63+50, and $54+00\pm$.

Existing storm crossing at STA 63+75 was identified as having leaks/damage to the existing pipe. Also, the contractor replaced the existing 24" RCP at STA 83+50. Three (3) 8' pieces of pipe were installed and a 24" concrete headwall was installed at the end of the pipe crossing.

Anticipated Work for Week of October 21, 2024

The contractor is expected to continue FDR for Phase 1 and expected to complete the FDR early in the week of 10/21/24. The 2^{nd} half of the pipe crossing that was replaced during the week of 10/14/24 will be completed the week of 10/21/24.
