The meeting was called to order by Deputy Director McDonnell at 12:00 p.m.

The Deputy Director called for a motion on Resolution No. 76 acknowledging personnel actions requested by or on behalf of Constitutional or Statutory Row Offices.

Deputy Director McDonnell opened the meeting to any member of the public who wished to address the Board of Commissioner.

Pamela Matukonis. 501 West Maple Avenue in Merchantville. I come today to ask for help. PSE&G dug up Maple Avenue last summer and put down temporary roading on top of it. It's not been repayed, and it's like, for those of you old enough to know, riding on the Hoochie Minh Trail. It is really bad and I've called them three times to find out what they're going to do about paving it, and I keep getting the same answer of "we haven't decided on a date yet." I talked to my local borough and they said they have no control over it and that it is up to the Camden County Board of Commissioners to get the help to do something about it. I'm asking for your help in getting the road paved. Deputy Director McDonnell asked Public Works Director Bob Harris if he was familiar with this project. Mr. Harris said yes, it will be scheduled to be paved before the end of November. Ms. Matukonis said the problem with that is when I called last October, they said it's too cold to pave and that they had to wait until the spring. Mr. Harris said that's why we're going to get it done by November. The Deputy Director asked Mr. Harris to give Ms. Matukonis his information so they could keep in touch as the project progresses. Ms. Matukonis said that would be really helpful. The second issue with Maple Avenue I'd like to address is the speed limit on that road, which is a County Road. It used to be 25 and somehow it got increased to 30. I live across the street from Wellwood Park, which has children constantly crossing the street to and from the park. That stretch of road between Browning and 130 has become a speedway. People going westbound go through the green light and think now 's the time to make it to 130 and they go a lot more than 30 miles an hour. And then those coming eastbound are trying to hit the green light and also consider it a speedway. Our police cannot just sit there all day long to catch speeders so I was wondering if it's possible to (a) reduce the speed limit back to 25; and (b) if there's a way we can put speed bumps down at the crosswalks at both ends of the park so that people at least have to slow down to go over the speed bumps, which is probably part of the paving issue, because someone's going to get killed. I was crossing the street with my dog a couple of weeks ago and the road was clear when I started out. But I almost got hit by a car crossing the street. I literally had to run, and I'm not a young person, to the other end of the street to get across it. It's really become a problem and I'm hoping you can help me with that. Deputy Director McDonnell said the county is responsible for the road, but I believe the speed limit is the jurisdiction of the municipality. Mr. Harris said that is correct. We have worked with other boroughs to install blinking pedestrian signs and I would be happy to look into that for you as well.

Renee DeFebbo, staff representative from AFSCME New Jersey and Frank Goad, Employee and union member. Ms. DeFebbo said I represent Local 2278. It is the New Jersey Pollution Control Financing. We have been in negotiations with Dave Luthman, and their last counter proposal came back at 2.75% a year for a four-year contract. It's a small bargaining unit with about nine or ten people and they have been dealing with three times the amount of tonnage that they had normally taken prior to the pandemic. Mr. Goad said since our previous contract, our tonnage has increased nearly 5%. On any given day, we receive between 300 and 1200 tons. We haven't seen a pay increase worthy of the cost-of-living increase or anything. We've been doing a lot more for the same money or less in the previous years. Mr. Luthman claims that he's limited by the county as far as negotiating an increase in our pay. We're just a small group looking to get a little bit of something to help us all out. He says the permission is granted by the Commissioners. I don't know if that is completely true because we are self-funded, we don't receive any money from the County. Any revenue we make comes in the gate that's in the way of extra volume, which goes on the back of a couple guys and for us to be doing four and five times the amount of work for less pay than we can afford. There's a lot of animosity. There's a lot of stress with the people. People are retiring early because they can't make it. I'm considering going out and getting another job. They need people that are skilled to run that facility and I don't feel as though it's being run appropriately or efficiently for that matter. Thank you.

Ms. DeFebbo said we have another meeting on the 26th and Michael DiPiero will be bringing another counter proposal and we are hoping it's something that we can bring back to the membership and they'll ratify the contract. Mr. Goad said don't get me wrong, we're very appreciative. You know, Dave 's been a great guy. However, I don't think he's been forthright negotiating with AFSCME's council. He claims that he doesn't have the authority to grant the increases and says he has to run it past the Commissioners. That's been a word that I've been hearing from a lot of people, that we all know somebody and they say no, Mr. Luthman, that's his ship. He runs it in the direction he wants. We don't want to kick any hornet's nest. I told that to Dave personally, as a friend. I said you can do what you want, but we as a small group of people would like a little money. It would really help a lot of people in this small group, and we haven't had an increase, like I said in many, many, many, many contracts. I've been there 36 years and haven't seen a good cost of living increase at all over any of our previous contracts. It's just gotten to the point where we can't afford to live anymore. The Deputy Director said, but you do get annual increases. Mr. Goad said, yes but they're minuscule compared to the cost of living and the consumer price index. With the economy the way it is right now, people are really struggling, and it wouldn't cost them anything to give everybody a handsome increase which would alleviate all the problems that everybody's feeling. We generate the revenue that comes in the gate. So, if they're making more money, which they're making a lot of money over and above what it costs to run the facility and facility is supposed to be nonprofit. What I am saying is if their revenue doubled in the last year, which is a very conservative figure, and we're nonprofit, where's the extra money going? Mr. Luthman told us it's not going in his pocket, I said, well, Sir, it's not going in our pockets either. We're just a small group of people and it wouldn't cost but one day's worth of trash to give everybody a considerable raise.

Deputy Director McDonnell said we obviously can't negotiate in public, that's Dave's job at the Authority, but we will certainly take your comments under advisement, and we do appreciate your coming here today. Mr. Goad said we came because we wanted to know who we were negotiating with and whether he has the final say or if it's you guys. Mr. Angilella said we don't have any jurisdiction over it. Mr. Goad said, so would that be stating that he has the authority and all these years, he's been saying no, I don't have the authority. He's acting as if he's limited. Mr. Angilella said I am not speaking for Mr. Luthman I am just saying we do not have jurisdiction.

Seeing no other members of the public wishing to comment, Deputy Director McDonnell asked for a motion to close the public hearing. Commissioner Nash made a motion with a second by Commissioner Betteridge and all Commissioners voted aye.

The Deputy Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said thank you, Deputy Director. First, let me say that your words regarding Laura Capelli were beautiful and meaningful, and I thank you for making those comments on behalf of this Board. I just want to add that my heart and prayers are with Commissioner Director Cappelli and his family on this incomprehensible loss. While the elected officials sit on this board and the employees of this county and the volunteers in this county are part of the government, it is not us alone that work here. It is also our families who are working to serve the public good and for that reason, Laura Capelli was a significant part of the fabric that makes up the Board of Commissioners and Camden County government. Laura was not only Lou's partner in marriage and work, but she was a very dear friend to us all. We are profoundly sad. We pray and offer support to Lou and his family during this difficult time.

Commissioner Young said it's been a very difficult last couple of days. My Heartfelt condolences to our dear friend Lou and his family.

Commissioner Kane said thank you Ed for your words and Jeff for your words. It's obvious by looking at everyone here that it has been painfully difficult this week and Jeff as you said we work together. We work together as a family with our families and we just need to hold all of us a little closer to check in on everyone. May Laura 's memory be for a blessing.

Commissioner Betteridge said thank you, Deputy Director. As my colleagues have shared their sadness, myself and my family, we stand with them. Laura was a beautiful light in our life. Lou has led this county for decades and has always supported all of us and our families, so the last couple of days have been reassuring to me that we are one team and one family, and I extend my deepest condolences to the Cappelli family and all those that are important to them. Thank you, Deputy Director, for your words and Jeff for always being his constant. It is really meaningful to be part of a group of people who care.

Commissioner Deputy Director McDonnell said I offer my thanks to all our great county employees for all the work they do for our residents every single day.

With love to Lou Cappelli, I ask for a motion to adjourn. Commissioner Betteridge made a motion with a second by Commissioner Nash and all Commissioners voted aye. The meeting was adjourned at 12:45 p.m.
