## **RESOLUTION 96**

The Director called for a motion on Resolution No. 96 acknowledging personnel actions requested by or on behalf of Constitutional or Statutory Row Offices. Hearing no one, that motion did not pass.

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Brian Hackett, Director of Government and Community Relations, Associated Humane Societies, 124 Evergreen Avenue, Newark. I wanted to thank Director Cappelli, Commissioner Nash and all the Commissioners generally for how wonderful Camden County has been in support of animal protection, causes and initiatives over the years Specifically, I wanted to chime in today thanking you all for the Resolution that was passed today in favor of State legislation, which is Senate Bill 2511 and Assembly Bill 4051 which is a Bill that would support all the humane pet businesses in our State and support responsible pet acquisition to ensure that New Jersey residents are not subjected to animals that are sourced from very cruel places that we call puppy mills and transported into the state. I'm very proud to say current legislation has over 25% of all the members in each of the Assembly and the Senate as official co-sponsors on the legislation, including a number of legislators who represent pieces of Camden County. We are working hard to make sure that this legislation passes for the sake of protecting consumers and protecting animals and supporting good humane businesses throughout the state. Just a point of reference for the Board, Camden County is, I believe, now the 11th county that has passed a resolution in support of the state legislation to this effect. Most recently, Hudson County and Atlantic County Commissioners passed similar resolutions in support of the state legislation. I appreciate the opportunity to share this information and I want to applaud all of you for your forward thinking and your leadership on so many animal protection issues over the years that are of so much importance to Camden County residents and more broadly throughout the State of New Jersey. I am often referring to the work of Camden County in a number of ways when I go around the state and work on these issues. So, thank you all very much. Director Cappelli said thank you, Mr. Hackett.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Deputy Director McDonnell made a motion with a second by Commissioner Young and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said I want to recognize the passing of former Mayor, Bernie Platt who was a legend in this county. He was our colleague as a Commissioner and Mayor for two separate terms combined for almost 10 years. His service was one of the most meaningful and heartfelt services that you could attend because his son Harry gave the eulogy and his grandchildren stood up and talked about their Pop Pop. They reflected on the person he was, not

only as a community leader, but also as a Dad. So I do want to recognize that and that the County had prepared a condolence resolution for that purpose.

Regarding the Resolution No. 37 that Brian talked about, I want to thank Brian Hackett who has been a long time leader and animal advocate in the State of New Jersey. Brian, I hope you're still listening. He has traveled the state from top to bottom left to right to talk about animal advocacy issues, not only on the puppy mill question, but on so many different issues. He fights the fight every day for those who cannot speak. Brian, you have done a great job. The legislation banning the sale of puppy mill dogs or animals was introduced after Camden County initiated that effort in 2015. We became the first county in the state to call for the band to prohibit the sale of puppy mill dogs in Camden County. Since that time, virtually every county has followed and over 150 million municipalities have followed. It's somewhat unfortunate that we did not become the first state in the country to ban the sale but I do believe that we have enough momentum to get it done this time. There are only 16 stores left the sell puppies from puppy mills. Hopefully it will close the door on that forever.

A note to the Parks Department. The parks had never looked better. I've been in this country for a very long time as well as the liaison to the Parks Department, so I get to see it every year. The parks are in spectacular condition and I am very proud of the work that the men and women do to clean the parks every day and to make sure that the landscaping aesthetically is perfect, but also the construction that is going on. There are over 60 projects that are in different levels of construction from engineering to ribbon cutting. Last week we cut the ribbon on a beautiful new softball field at Cooper River Park. We are going to have a groundbreaking next week or the week after for the skateboard park. We have playgrounds being installed throughout the county and so every municipality, every corner of Camden County is having some work being done. I am very proud of them. I see that the Recycler came out today. That is something the Environmental Affairs team works on all year round and it looks great.

Commissioner Young said I want to thank all of our county workers for doing a fantastic job. As we move into the fall weather our sustainability program will start to ramp up and get a little busier. Our Farmer's Market has launched with Triple Oaks Nursery. The market is open Thursdays from 3:00 to 7:00 and we have extended the time through the end of October. The Office of Sustainability and the Camden County Certified Gardeners, in partnership with the Office of Environmental Affairs, have been hosting an educational series on backyard composting through September at locations in Camden, Cherry Hill and Gloucester Township. There are still spaces available for workshops being held next Wednesday evening beginning at 6:00 PM at the Camden County Municipal Utilities Authority Administration Building in Camden. Residents pay a small fee to leave with a beautiful backdoor composter. You can check our website for details on how to register. The Certified Gardeners are also partnering with Cedar Run Wildlife Refuge this Saturday for Wildlife Adventures for Young Mind programs at 10 AM at our Sustainability Campus. They are also hosting a Make It and Take It workshop on our Campus on Saturday the 28th at 10 AM. This month's topic is plant propagation and keeping plants through the winter months. It is also that special time our Director really loves when we get to harvest our grapes. We are in partnership this year with Saddle Hill and we will harvest the grapes next week. We will go to Saddle Hill and do a big presentation to them. We are glad to have them as a partner this year because we have Blue Ribbon Glen grapes that we grow right here in Camden County at our Sustainability Campus. They're always going to great job down there.

Commissioner Kane said I just want to start by saying this I miss being with all of you in person. I wanted to follow up on what Commissioner Nash said about the funeral service for Bernie Platt. As a 90-year-old man passing, the love and how he has touched so many people was just so evident and in his role as a Mayor and as a Freeholder but also as a funeral director and how he interacted with people in the worst of times and consoled and just did things without recognition or acknowledgement to help people within our community. I just wanted to thank him for his lifetime of service. If you look up the definition of Mensch, I believe Bernis Platt's name is next to that definition.

Last week on September 11th, it was the 23rd anniversary of that horrible event in our nation's history. There were several events going on within the County. We partnered with the City in a 9/11 ceremony outside of City Hall. Throughout our community there were services in recognition including American Water who did a beautiful placement of flags on the waterfront, just showing that we are not going to forget that day in our history. As a County, on the evening of September 11th, we had a remembrance medal ceremony at Cooper River Park, which is always very, very meaningful and emotional. We recognized 6 individuals who were first responders on that day and those who had been in the military in the war and subsequent wars on terror. I just wanted to acknowledge and be grateful that we live in a community that history is remembered, and lives and service and sacrifice is honored and remembered as well.

Commissioner Dyer said the summer concert series was great. I want to thank Roland Traynor. During my four years as a Commissioner this was the most I was able to interact and speak to the crowd. The line up was great. It was well attended. I think we had 10,000 people for Jeffrey Osbourne. Jeffrey was walking through the crowd and interacting. I tell people all the time that they have to attend these concerts. Its great to see residents from all over Camden County come out to enjoy some great music. Thank you Bob Harris. Bob lost a key member of his team, Julia Downes, and we have not lost a beat at the Department of Public Works because of his leadership. From me and the Commissioners, continue to do what you do. We appreciate you.

Commissioner Betteridge said as the summer is winding down, there are a couple of announcements to remind everyone. The tri-valent flu vaccine is now available. The kickoff will be at the Forum Catering Hall on Wednesday, October 9th from 10:00 AM – 2:00 PM. The Forum is located on the Black Horse Pike in Blackwood. We had a successful immunization program for school-aged children. I believe there were a couple 100 in attendance. The beauty of that wasn't just the 200 different types of immunizations that we were able to provide to the children but we were able to offer other services as well. They were able to go to other areas of the county and meeting county programs and county stakeholders to receive additional help that the family may be lacking. So kudos to the Health Department for spearheading this. It was our first year and it was very successful. We had two confirmed cases of West Nile Viruses and 3-4 probable cases. So that is a total of 4. Protection is really needed. If you are a proponent of using Deet it's probably one of the best ways, but if you'd like to use the natural approach, lemon and eucalyptus oil works very well and long sleeve clothing. Also, for the residents, just as a reminder to please remove standing water that is in and around your property. It's really important for all of us to do our part to make sure that we don't continue to see a spike in the West Nile virus.

As a Hispanic, I was very proud on Monday evening, with the support of the Camden

County Board of Commissioners, to be part of the awards ceremony honoring 13 Hispanics in Camden County. We gathered at 5:00 PM at Wiggins Parks. We celebrated by breaking bread and then we walked to the main stage and brought the 13 honorees up and presented them during the final concert of the season and it was well attended. We received a lot of positive feedback and I just want to extend a thank you to everyone that participated to make sure that September 15<sup>th</sup> through October 15<sup>th</sup> the Latin/Hispanic community is being honored here in the county of Camden.

On November 14<sup>th</sup> the Camden County Board of Commissioners are hosting another conference in a series. This one is on food insecurity and is for providers. If anyone would like to attend, please reach out to my office and we will make sure that when the invitation is completed that we send it out.

Commissioner Deputy Director McDonnell said I want to join Jeff Nash in congratulating Scott Traynor and all the employees at the Parks Department. The parks are really in great shape from one end of the county to the other. Congratulations Jeff and Scott. I also want to thank all the employees of Camden County for all the great work they do every day on behalf of our citizens.

Commissioner Director Cappelli said I too want to express my condolences and sympathies to the family of Bernie Platt. Bernie was always a great public servant who put the people he represented first before anything. He was certainly great role model for everybody in Cherry Hill and Camden County. I would like to also thank all the employees of Camden County for the great work they do day in and day out for our residents.

The Director asked for a motion to adjourn. Commissioner Young made a motion with a second by Commissioner Nash and all Commissioners voted aye. The meeting was adjourned at 12:28 p.m.
